I hereby pledge the following when applying for the Okazaki City Coronavirus Infection Control Cooperation Grant (hereinafter "Cooperation Grant").

- Application for the Cooperation Grant shall be withdrawn if any falsehoods or fabrications are found in the application paperwork. In addition, if such a discovery is made after transfer of funds, the Cooperation Grant funds shall be returned.
- The photocopies of documents submitted are no different in their content from the original documents.
- The Cooperation Grant is being applied for in just one city, and not applied for in multiple cities.
- All off the business's locations in Aichi subject to suspension of operations or reduction of hours complied.
- As a business operator cooperating with the request for suspending operations, I agree to the name of the issuing municipality, the name of the corporation (shop name the name of the sole proprietor is a store name), the corporation number (In the case of corporation), and the type of facility will be posted on the Aichi Prefecture homepage.
- I consent to check of taxpayer information and payment status, and to a check of the application contents for falsehoods if deemed necessary by the governor or the mayor.
- Representatives, officers or employees or other employees or members, etc. do not correspond with a gang as stipulated in the Aichi Prefectural Gang Exclusion Ordinance, Article 2, Section 1, gang members as stipulated in Article 2 of the same ordinance, or other gang affiliate members as stipulated in Article 3 of the same ordinance, and will not correspond in the future. In addition, no gangs, gangsters, or gang affiliates, etc. mentioned above are not participating in the management in actuality.
